### 5. Grants

The PTA has requested a grant towards the event of up to  $\pounds$ 1,000 – which would match their primary supporter.

### 6. Co-Options

There is currently a casual vacancy on St Andrews Parish Council, due to the resignation of Cllr Emma Faramarzi. The vacancy arising from Cllr Faramarzi's resignation has been advertised in accordance with the legislation; Electors of the Parish did not demand an election, and the vacancy has been returned to the Council for Co-Option.

It would be normal now for the Council to advertise this as a co-option vacancy. Anyone within the parish who qualifies to stand as a parish councillor can apply to be co-opted by speaking to a councillor or a council officer who can advise of next steps.
