RESOLVED to send the following objections to Swindon Borough Council:

"St Andrews Parish Council wish to object to planning application S/HOU/24/1176 due to the reduction in parking. The application clearly identifies only one parking space on the applicants own driveway and a second space identified on the opposite side of the highway. St Andrews Parish Council believes that the second space identified is on the public highway and not for the exclusive use of 59 John Ruskin Road, but rather an access point for neighbouring properties and was not designated as a "parking spot" within the highway.

St Andrews Parish Council also wish to draw attention to the wording of this application. It would appear from the drawings that the extension is to the side of the existing property (replacing a carport); the description of works is for:

"Erection of a single storey rear extension and associated works"

St Andrews PC have noted the comments from the neighbouring property 66 John Ruskin Road.
